### **Job Description:**

As a Quality Inspector you will be assisting the Chief Inspector and Quality Manager in returning aircraft turboprop engines and engine components back to service during routine inspections and repairs. Additionally, you will be assisting the Chief Inspector and Quality Manager in designing, implementing and maintaining procedures to adhere to the appropriate aviation regulatory standards.

### **Essential Job Functions**

1. Research aircraft turboprop engine maintenance records and compile work scopes.
2. Inspect aircraft turboprop engines and engine components during the maintenance, repair and overhaul process.
3. With some to limited supervision, return aircraft engines and engine components to service by completing all required documentation once the work has been completed.
4. With some to limited supervision, prepare various documents required by Company policy and FAA regulations. Demonstrates proficiency of Turbine Standard work order system by completing corrective action statements, Service Bulletins and Airworthiness Directives (AD), and compliance statements.
5. Assist in obtaining EASA Safety Management System certification and AS9100 Certification.
6. Assist in designing and implementing various training programs.
7. Locate and use appropriate technical data, follow verbal instructions and accept directions from supervisor when accomplishing assigned tasks.
8. Performs other related duties as assigned supervisor.

### **Job Specific Requirements**

- **Attendance:** Regularly scheduled attendance required.
- **Physical:** Read small print; hear sounds associated with mechanical deficiencies; tolerate products, materials and fumes associated with aircraft engine and component maintenance.
- **Environmental:** Shop environment Occasionally subject to varied weather conditions and elevated noise levels.

- FAA Airframe and/or Power plant license is not required, but preferred.
- FAA Part-145 Repair Station experience preferred.
- SMS and AS 9110 program design and implementation experience preferred.
- FAR Part-145 Training program design and implementation experience preferred.
- Must be well versed in Microsoft Office applications, including Word, Outlook, Excel and PowerPoint
- Possess polished and professional interpersonal skills with a positive attitude and a customer-oriented mindset
- Must have well-developed people skills and ability to work with a variety of personalities.
