#### **Job Description:**

As a General Electric CT7 engine technician you will be assisting in the tearing down, inspecting, reassembly and testing of CT7 aircraft turboprop engines during routine inspections and repairs.

#### **Essential Job Functions**

1. With some to limited supervision, assist in high quality inspections, servicing, troubleshooting, and maintaining of aircraft and engine systems and components on a General Electric CT7 engine using proper tooling in a timely, clean, safe and professional manner. Accurately orders required parts as needed.
2. With some to limited supervision, prepare various documents required by Company policy and FAA regulations. Demonstrates proficiency of Turbine Standard work order system by completing accurate and timely discrepancies and corrective action statements, Service Bulletins and Airworthiness Directives (AD), and compliance statements.
3. Locate and use appropriate technical data, follow verbal instructions and accept directions from other shop personnel when accomplishing assigned maintenance tasks.
4. Performs other related duties as assigned supervisor.

#### **Job Specific Requirements**

- **Attendance:** Regularly scheduled attendance required. Overnight and short notice travel may be required on occasion.
- **Physical:** Routinely lift up to 50 lbs. and occasionally up to 100 lbs.; read small print; hear sounds associated with mechanical deficiencies; repetitive motion; work with moving parts and vibration; tolerate products, materials and fumes associated with component maintenance; tolerate working in confined spaces and heights above four feet; tolerate standing, walking, bending, kneeling, stooping, crouching, crawling, climbing and sitting.
